GENERAL APPLICATION GUIDE:

For best performance and friction reduction, all areas where cable and conduit will touch should be lubricated. Cable lube should be applied to the cable and spread evenly as the cable is pulled through the conduit. If a cable pull is long or cumbersome, lubricant can be injected directly into the conduit prior to a pull. If using this technique, the cable should also be lubricated. Product can be applied through a squeeze bottle, sprayed, brush or wiped with hands.

STORAGE:

Optimum storage conditions are under cool, dry conditions. Ideal to store containers out of direct sunlight. Always store containers with lids securely attached.
