



RLA Carpet Seam Adhesive



DESCRIPTION:

RLA Carpet Seam Adhesive is an extrudable solvent-based neoprene contact-type adhesive. This adhesive is designed to bond carpet seams together and displays good water and heat resistance once cured.

RECOMMENDED USE:

Carpet seam edges together where the carpet is either directly bonded to the floor or double bonded over underlay.

APPLICATION:

Seams must be clean, dry and free from adhesive. Starting at one end of the seam, apply a 3.0mm bead along the seam length using a Seam Adhesive Applicator.

COVERAGE:

Approximately 40- 50 LM per 1 litre, depending on application and site conditions.

CONTAINER SIZES:

1-litre Plastic Bottle

CLEAN UP:

To clean up equipment and adhesive spills, use a suitable cleaning solvent.

SHELF LIFE / STORAGE:

6 months when stored in original unopened packaging To be stored in a dry area off the ground.

RISK:

SAFETY & HANDLING:

- Wear suitable respiratory protection.
