

# CURECON AA

## WATER BASED, ALIPHATIC ALCOHOL FINISHING COMPOUND



### DESCRIPTION

CURECON DOUBLE A is a water based, aliphatic alcohol finishing compound designed for use on plastic (freshly poured and screeded) concrete, to reduce the rapid evaporation of water during finishing operations. CURECON AA will not normally interfere with subsequent toppings and common finishes including tiling, render and surface coatings

### FEATURES & BENEFITS

- Water based
- Reduces evaporation of water from the concrete surface
- Improves finishing properties in adverse weather conditions
- Reduces shrinkage cracking through premature drying
- Does not interfere with following trades and finishes

### USES

- To reduce rapid evaporation of water from freshly poured concrete

### APPLICATION

#### Mixing:

- Stir contents thoroughly before use
- Pre-dilute CURECON AA with clean water in a clean mixing pail or vessel at the following ratio:

**1 part CURECON DOUBLE A**  
**9 parts water (by volume)**

- Mix thoroughly to combine prior to application.

#### Application

- Application is by low pressure backpack type spray
- Decant mixed solution into sprayer and apply evenly over the concrete surface immediately after screeding ensuring full coverage
- CURECON AA should be re-applied each time the surface is broken (i.e. screed, bull float, troweling).

### COVERAGE

- Approximately 1litre per 5-7m<sup>2</sup>

### CLEAN UP

- Clean all equipment with water while wet
- Once dry, use a 1:1 solution of methylated spirits and mineral turpentine to remove

### SHELF LIFE / STORAGE

- 12 months when stored in original unopened packaging
- Best stored in a dry area at room temperature
- Keep off cold floors and out of direct sunlight
- Curecon AA may "layer" when stored for extended periods of time. Stir thoroughly before use

### CONTAINER SIZES

- 20litre containers and 200Litre drums

### PRECAUTIONS

- Do not apply CURECON AA to surfaces with excessive bleed
- Mix only the amount of product likely to be needed for each application. Mixed CURECON AA is not recommended to be stored.
