RLA REDNACURE is a high solids, polymer emulsion specifically formulated for the curing of concrete where after trades are to be applied. The specially selected polymers contained in RENDACURE produces a fast drying membrane without the associated problems of wax or solvent based coatings.

<u>USES</u>

- As a curing compound over new concrete where after trades are to be applied
- Dust sealer for old concrete surfaces

APPLICATION

- · Stir the contents of the drum before application
- No mixing or dilution is necessary use Rendacure as supplied to ensure optimum results
- When using Rendacure as a dust sealer on old concrete, ensure the surface is clean and free of oils and other contaminants
- For optimum water retention in new concrete, apply the Rendacure as soon as possible after the disappearance of any surface water and final troweling
- The green fugitive dye assists with obtaining an even coverage
- Apply the Rendacure to the substrate using a brush roller or low pressure sprayer
- Avoid letting the membrane pool in any low spots on the floor
- Areas which quickly absorb the curing compound may require a second coat to adequately seal the substrate. On vertical surfaces apply the curing compound as soon as the formwork is removed.

COVERAGE

• Approximately 1litre per 5m²

NOTE: Coverage rates may vary subject to substrate porosity

DRY TIMES

• 30 minutes @ 20°C, 50% RH

<u>NOTE:</u> Drying times may vary subject to ambient/surface temperatures, humidity and substrate porosity

<u>CLEAN UP</u>

• Excess primer, tools and general equipment with water immediately after use while the product is still wet.

SHELF LIFE/STORAGE

- 12 months when stored in original unopened packaging
- · Best stored in a dry area at room temperature
- · Keep off cold floors and out of direct sunlight

- Do not apply RLA Rendacure A when surface or ambient temperatures are above 40°C or below 0°C Where temperatures less than 0°C or greater than 40°C are encountered, contact RLA Technical Department for specific advice
